**Subject:** NYSE Arca Options: TSLA UPDATE - Bid/Ask Differentials Effective through the March 20, 2020 expiration cycle

In accordance with NYSE Arca Rule 6.37-O(b)(4), OTP Holders will adhere to the maximum bid/ask differentials for quoting electronic obligations as delineated in the rule. However, due to the high price and/or high volatility, pending news, news announcement or other special event of certain underlying securities, the Exchange may establish modified bid/ask differentials for certain issues. Pursuant to Rule 6.37-O(b)(5) and (c), Trading Officials have established modified quote differentials as outlined below. Modified differentials will be in effect through the **March 20, 2020** expiration cycle.

The following modified bid/ask differentials will be in effect for the entire trading day, including the opening auction, for all option series associated with the following securities (changes and new additions highlighted):

The modified differentials will be in effect for the entire day including the opening auction in the following:

AMZN, BKNG, FAANG, GOOG, GOOGL, **TSLA** - Modified bid/ask differentials granted for **electronic quotes**:

Bid is up to (and including) \$100.00	\$20.00 wide
Bid is greater than \$100.00	\$25.00 wide

AMZN, BKNG, FAANG, GOOG, GOOGL, **TSLA** - Modified bid/ask differentials granted for **open outcry**:

If the bid is less than \$2.00	\$0.75 wide
If the bid is from \$2.00 - \$4.99	\$1.00 wide
If the bid is from \$5.00 - \$9.99	\$1.50 wide
If the bid is from \$10.00 - \$19.99	\$3.00 wide
If the bid is from \$20.00 - \$39.99	\$6.00 wide
If the bid is from \$40.00 - \$79.99	\$12.00 wide
If the bid is from \$80.00 - \$199.99	\$18.00 wide
If the bid is \$200.00 or greater	\$22.00 wide
